6.3. Methods and material for containment and cleaning up

Contain spill. Working from around the edges of the spill inward, cover with bentonite, vermiculite, or commercially available inorganic absorbent material. Collect as much of the spilled material as possible. Place in a closed container approved for transportation by appropriate authorities.
